NWWS MEMBERSHIP

<u>Waterworks Online</u> is open to all <u>CURRENT NWWS members</u>. You must be a current member or become a member of NWWS at <u>www.nwws.org</u> *prior* to entering the exhibition. Dues are \$50/yr.

CONDITIONS & RULES

PLEASE READ CAREFULLY: Failure to meet ANY of conditions 1 through 10 may result in disqualification of your entry and ineligibility to enter future NWWS exhibitions for two (2) years (spanning 4 NWWS exhibitions). NWWS reserves the right to inspect and refuse any painting that does not meet the criteria below:

- 1. **AGE** Member artists must be 18 years or older.
- 2. **ORIGINALITY** Your entries *must* be original works of art, painted only by you. Paintings produced in a class, workshop, or submitted to an NWWS AZR critique session are not eligible. Photo references <u>must have been taken by you, the entrant.</u> Public domain vintage photos may be used but not wholly replicated. Photo references *NOT allowed* include purchased images, permission-granted photos taken by others, stock photos, royalty-free images, copyrighted images published or unpublished. <u>Artwork created from an AI generated (artificial intelligence) image is not allowed</u>.
- 3. **SUBSTITUTIONS & WITHHOLDING** Artists <u>may not substitute</u> another work for an accepted work nor withhold the work for any reason.
- 4. **EXCLUSIVITY** Accepted work in an NWWS exhibition must not be displayed or sold through any other gallery or online exhibition during the same period as the NWWS exhibition, including 30 days before and 30 days after.

- 5. **CURRENT WORK** Entries must have been <u>completed after January 1, 2023</u> and NOT ACCEPTED into any previous NWWS juried exhibition.
- 6. **SUBSTRATES & MEDIA** Entries must be watermedia on an archival, 2-dimensional substrate, natural or synthetic. Watercolor, acrylic, gouache, egg tempera plus other watermedia are allowed and listed on the FAQ page. **You are responsible for reviewing the Waterworks Exhibition FAQ page at www.nwws.org for additional media criteria**. Allowed media must occupy at least 90% of your painting. No more than 10% of your painting may be your choice of any archival material.
- 7. **COLLAGE** All collage materials must be original designs and painted by you using NWWS accepted watermedia. If collage materials are used on no more that 10% of the painting, any art media is allowed. Pre-printed collage materials are NOT allowed.
- 8. **SUBJECT MATTER** Nude representations are not allowed.
- 9. **PAINTING SIZE** Original paintings must be a <u>minimum of 7" in any dimension</u>. No diptychs or triptychs are allowed.
- 10. **SALES** Entries must be for sale, priced with intent to sell, and in alignment with your typical selling prices. Once entered, the price of your painting cannot be changed. Artist receives 75% of the sales price. NWWS is due a 25% commission on all accepted paintings sold 30 days before or 30 days after the exhibition dates.

ARTWORK PRICING

- <u>Price your painting(s) WITHOUT framing costs included.</u> Buyer requested framing style and resulting
 cost are to be coordinated directly between the buyer and artist.
- <u>Shipping/delivery charges should NOT be included in the sale price.</u> Shipping/delivery charges and payment arrangements are to be coordinated between the buyer and artist.

HOW TO ENTER

- Submit ALL entries using the NWWS online entry form (you must be a member and logged in):
 https://www.nwws.org/annual-waterworks-exhibition/
- If you start your entry process and save the form to finish later, any images you've uploaded will not be saved. You must re-upload your entry images as you finish your entry submission.
- <u>Up to three paintings per artist</u> may be submitted, but <u>only one painting can be accepted</u> into the exhibition. **All entries must be entered at the same time and on the same entry form.**
- IMAGE REQUIREMENTS: Please read carefully!
 - Submit digital entry cropped cleanly to ONLY the painting image. No frame. No mat.
 - Each digital entry must be a minimum of 1600 pixels on the longest side
 - Each digital entry must be a .jpg (or .jpeg). Maximum file size is 5 MB, no larger.
- ASSISTANCE WITH IMAGE EDITING/RESIZING:

There are many free image editing platforms available online, with easy-to-follow instructions.

ENTRY FEE

- <u>FEE:</u> \$30 for one entry; \$40 for two entries; \$50 for three entries.
- Payment may be made online during the entry process, or a check sent by US mail. **Entry fees are non-refundable!**
- <u>Payment by US mail:</u> Make check payable to NWWS. Include a copy of your confirmation email along with your check immediately after entering. (See mailing address below.)

<u>New or renewing members</u> may add the \$50 membership fee to your entry fee in one check. Download and fill out the PRINTABLE MEMBERSHIP FORM linked on our <u>Join/Renew</u> page and include it with your entry confirmation and check.

Your payment must arrive at the NWWS postal box no later than February 3, 2025.
